## Farm Visit 農場考察

Saturday, 5 November 2011

<b>Description</b>	<p><b>The first site: 楊氏水產</b></p> <p>Agriculture, Fisheries and Conservation Department implemented a voluntary "Accredited Fish Farm Scheme" in mid 2005 to enhance competitiveness of the local aquaculture industry. Participating fish farms under the scheme are required to adopt a set of good aquaculture practices with a view to raising the environmental hygiene standards of the farms and the quality of cultured fish. Quality assurance tests, including analyses of drug residues and heavy metals in fish, are conducted to ensure that all cultured fish meet food safety standards before they are sold at market. The fish farm to be visited was one of the first batches of the cultured fish accredited under the scheme in 2005. Gray Mullet cultivated in the farm is very famous for many years.</p> <p><b>The second site: 康和健康農產品有限公司 (HONWAL Healthy Agro Products Co. Ltd.)</b></p> <p>Kamei Chicken was developed by The Hong Kong University and Kadoorie Agricultural Research Institute, and cultivated in Hong Kong. Kamei Chicken was developed through gene sequencing by high-tech methods, reproduced by natural mating and with basic fodder. Apart from the improvement on production rate, protein ratio, chick bone collagen and texture, it lowers the level of male hormone and estrogen, and enhances resistance of Kamei Chicken against bird flu.</p>
